Group events are also held with all mentor/mentee teams and individual connections and relationships are formed between mentors and mentees to assist transition age foster youth with their transition to independent adult life.ImpactJLS D provides a variety of services to the San Diego community through short, intensive projects that are completed in a single day. This includes projects such as serving meals to families in need due to a medical crisis, providing sack lunches for the homeless and working with San Diego area food banks, working with transition age foster youth, at schools and playgrounds, working with transition, military families at large work projects and assisting other local non-profit organizations.Advocacy JLS D is committed to serving the needs of women and youth in the San Diego community through effective legislative and community advocacy efforts. JLS D takes action on state issues that affect our projects and mission while focusing on the communities we directly serve. Relating to such issues, we educate our members and the San Diego community while fostering collaboration and communication with community partners.
